**RECOMMENDING TO THE HEAD OF PROCURING ENTITY [HOPE] THE APPROVAL OF THE NOTICE OF AWARD TO THE PINNACLE HOTEL AND SUITES AS THE SUPPLIER WITH THE SINGLE CALCULATED AND RESPONSIVE BID**

**WHEREAS**, the procurement of One (1) lot Food and Accommodation in Davao City on May 28-June 1, 2018 was undertaken as prescribed in Section 53.9 Negotiated Procurement- Small Value Procurement of the 2016 Revised IRR of R.A. 9184;

**WHEREAS**, the Requests for Quotations (RFQs) indicating the specifications, quantity and Approved Budget for the Contract (ABC) for the above mentioned procurement were sent to suppliers of known qualifications and were advertised in the PhilGEPS wherein three (3) suppliers responded, the details are as follows:


