**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THE  
APPROVAL OF THE NOTICE OF AWARD TO SEARCA AS HAVING SUBMITTED THE  
SINGLE RATED RESPONSIVE BID RELATIVE TO PCAF'S PROCUREMENT OF  
CONSULTANCY SERVICES**

**WHEREAS**, the PCAF had issued a Request For Expression of Interest for the Procurement of Consultancy Services for the Conduct of Evaluative Study entitled "Intensive Use of Mechanized Technology in Agriculture Sector: An Evaluation of the Effects and Implications In Selected Commodity Value Chains"

**WHEREAS**, only one prospective bidder (SEARCA) applied for eligibility check, in accordance with the provisions of the IRR, and met the eligibility requirements or criteria; after which it submitted a bid which was found to be responsive to the bidding requirements; 0117091504

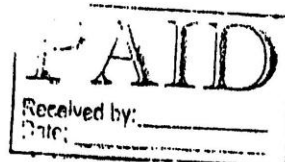
**WHEREAS**, as the sole bidder, SEARCA has passed the Technical and the Financial Evaluation which was given a rating by the BAC TWG of 100 %, and was concurred by the members of the BAC, based on the Quality Cost Based Evaluation (QCBE) procedure on a given set of criteria;

**WHEREAS**, the BAC has determined that SEARCA complied with and is responsive to all the requirements and conditions specified in the bidding documents and passed the criteria for post qualification and should be declared as the Single Rated Responsive Bid;

**NOW THEREFORE, BE IT RESOLVED** as it is hereby resolved, that the BAC recommends to the Head of the Procuring Entity (HOPE) to award to SEARCA the procurement of the said Consultancy Services in the amount of **Eight Million Nine Hundred Ninety Six Thousand Nine Hundred Seventy Eight Pesos (PhP 8,996,978.00)** as having offered the Single Rated Responsive Bid;
