WHEREAS, the lowest bidder, **WORK HABITS TRADING** complied with the PCAF specifications, submitted Certificate of PhilGEPS registration, and was within the ABC; thus, was considered the Lowest Calculated and Responsive Bid;

WHEREFORE, RESOLVED AS IT IS HEREBY RESOLVED, that we, the members of the BAC, recommend to the HOPE to award the above mentioned procurement to **WORK HABITS TRADING** in the amount of **Sixty-Seven Thousand Five Hundred Pesos (Php 67,500.00)** being the Lowest Calculated and Responsive Bid;






