KNOW ALL MEN BY THESE PRESENTS:

This Contract made and entered into this **23rd day of June 2018** by and between:

The **General Santos Real Hotel Development Corporation**, herein represented by **JESSA FREDILES**, Sales and Marketing Supervisor, with address at National Highway, General Santos City, Philippines.

-and-

The **PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES** herein represented by **SARAH GUTIERREZ-CAYONA**, with office addresses at Apacible Hall, Department of Agriculture Compound, Eliptical Road, Diliman, Quezon City.

WITNESSETH

That **General Santos Real Hotel Development Corporation** and **PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES**, in consideration of the mutual covenants and agreements made by one to the other, by these presents, are bound by the following terms and conditions to wit:

1. That the **PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES**, will be having a live-in seminar at East Asia Royale Hotel on **JULY 3-6, 2018** with a total bill amounting to **Nine Hundred Ninety-Seven Thousand Two Hundred Pesos (P997, 200.00)**.

 - Hotel has elevator, ample car park and accessible to malls and hospitals.
 - 24 hours room service
2. That the abovementioned room and banquet reservations are considered as guaranteed by the **PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES**. This assures payment regardless of unconsumed food and unoccupied rooms based on the reservation. Such is primarily because the reserved rooms have been blocked exclusively for the **PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES** on the aforementioned dates; hence other bookings were not accommodated.
 3. That the **PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES** is requested to pay fifty percent (50%) of the total bill upon signing of the contract and the remaining room and banquet bills incurred during the reservation dates shall be paid within 5 days upon the receipt of the billing statement.
