THIS AGREEMENT made this 31 day of July 2017 between **PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES [PCAF]** of the Philippines [hereinafter called "the Entity"] of the one part and **MASANGKAY COMPUTER CENTER** of 1143G, Masangkay Street, Sta. Cruz, [hereinafter called "the Supplier"] of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., Supply and Delivery of various Information and Communication Technology ([ICT] and Office Productivity Equipment for PCAF Personnel Under the Government-Wide Medium-Term Information and Communication Technology Harmonization Initiative [MITHI] for a total sum of **FIVE MILLION NINE HUNDRED SIXTY-SIX THOUSAND ONE HUNDRED EIGHTY-EIGHT PESOS (PhP5,966,188.00)**, herein called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement viz.:
 - a. The Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - b. The Schedule of Requirements;
 - c. The Technical Specifications;
 - d. The General Conditions of Contract;
 - e. The Special Conditions of Contract;
 - f. The Performance Security; and
 - g. The Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payables under the provisions of the contract at the time and in the manner prescribed by the Contract.
