**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THE
PROCUREMENT OF CONSULTANCY SERVICES THROUGH NEGOTIATED
PROCUREMENT AGENCY-TO-AGENCY AGREEMENT WITH THE DEVELOPMENT
ACADEMY OF THE PHILIPPINES (DAP) FOR THE CONDUCT OF POLICY STUDY ON
THE IMPLICATIONS OF THE BANGSAMORO BASIC LAW (BBL) ON THE FISHERIES
SECTOR**

WHEREAS, it is a paramount commitment of the Government of the Philippines (GOP) to promote good governance and to adhere to the principles of transparency, accountability, equity, efficiency, and economy in its procurement process in accordance with RA 9184, otherwise known as "Government Procurement Reform Act."

WHEREAS, Purchase Request No. 18-06-0408 for the procurement of Consultancy Services for the conduct of the Policy Study on the Implications of the Bangsamoro Basic Law (BBL) to the Fisheries Sector will be undertaken by the Development Academy of the Philippines (DAP) in accordance with the Revised IRR of RA 9184 on the use of Alternative Methods of Procurement such as Negotiated procurement through Agency-to-Agency Procurement;

WHEREAS, Cost Benefit Analysis (CBA) conducted by the end-user for the conduct of the said policy study has determined that entering into a Negotiated Procurement Agency-to-Agency (Section 53.5 IRR of RA 9184) agreement with the Development Academy of the Philippines (DAP) is more efficient and economical to the government, furthermore, it has the mandate and the absorptive capacity to undertake the study. (see attached);

WHEREAS, based on the assessment and recommendation of the End-User unit and after a thorough deliberation and discussion, the BAC has agreed to adopt a resolution recommending to the HOPE the procurement of the said consulting services requirement of PCAF for the approved project through Negotiated Procurement Agency-to-Agency with the Development Academy of the Philippines (DAP);


