Stage 1 and Stage 2 Audit fee shall be paid on or before the certification audit date; c. All bank charges shall be borne by PCAF; and d. 2% interest calculated monthly shall be charged on all outstanding amounts. 4. TUV Rheinland PH, Inc. is the lone complying for the said requirement.




