KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered into this 19th day of September 2018 in the City of Zamboanga, Philippines by and between:

The **GRAND ASTORIA HOTEL**, a private agency created under the laws of Republic of the Philippines with business address at Mayor Jaldon Street, Zamboanga City represented by **DANNY LIM**, General Manager hereinafter referred to as the **FIRST PARTY**:

WITNESSETH

WHEREAS, the First Party is engaged in the Business of providing training facilities including board and lodging services, training rooms and facilities at such reasonable cost as agreed upon for occasion such as conferences, conventions, live-in seminars, workshops and group activities.

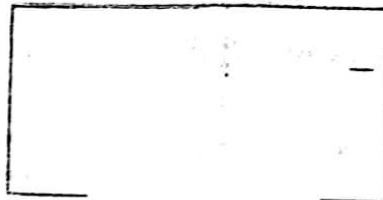
WHEREAS, the Second Party desires to avail of the aforesaid services for the purpose of holding their live in seminar on September 25-28, 2018.
