
WHEREAS, COLOR1 DIGITAL, INC.'s bid of Two Hundred Thirty-Six Thousand Pesos (Php236,000.00) was corrected to Two Hundred Thirty-Five Thousand Nine Hundred Eighty Pesos (Php 235,980.00);






