**WHEREAS**, the procurement of Ten (10) units of Steel Shelving- Open Type was undertaken as prescribed in Section 53.9 Negotiated Procurement- Small Value Procurement of the 2016 Revised IRR of R.A. 9184;

**WHEREAS**, the Requests for Quotations (RFQs) indicating the specifications, quantity and Approved Budget for the Contract (ABC) for the above mentioned procurement were sent to suppliers of known qualifications and were advertised in the PhilGEPs where six (6) suppliers responded, the details are as follows:

**WHEREAS**, the **IKF HOME FURNISHING & OFFICE FURNITURE, FURN APT DESIGN CORPORATION, ALPHA STEEL OFFICE HOME FURNISHING** and **MAGNETO ENTERPRISES**, the second, third, fourth and fifth lowest bidder respectively, complied with PCAF specifications, submitted Certificate of PhilGEPS registration and were within the ABC;

**WHEREAS**, the lowest bidder, **SEE MANUFACTURING CONTRACTOR**, whose offer of gray color instead of almond beige for the item was acceptable to the user, and had complied with the PCAF specifications, submitted Certificate of PhilGEPS registration and was within the ABC, hence, declared as the Lowest Calculated and Responsive Bid.


