RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THE FAILURE OF PUBLIC BIDDING FOR THE PROCUREMENT OF ONE (1) YEAR JANITORIAL SERVICES TO MAINTAIN CLEANLINESS AND SANITATION OF PCAF OFFICES AND ITS PREMISES (2019) AND ITS IMMEDIATE REPOSTING

WHEREAS, it is a paramount commitment of the Government of the Philippines (GOP) to promote good governance and to adhere to the principles of transparency, accountability, equity, efficiency, and economy in its procurement process in accordance with RA 9184, otherwise known as "Government Procurement Reform Act.";

WHEREAS, an Invitation to Bid No. 2018-02 for the Procurement of One (1) Year Janitorial Services to Maintain Cleanliness and Sanitation of PCAF Offices and Its Premises (FY 2019) with an Approved Budget for the Contract (ABC) of Two Million One Hundred Seventy-Five Thousand Nine Hundred Ninety-Five Pesos and Fifty-Two Centavos (PhP 2,175, 995.52) was posted in the PhilGEPS along with its Bidding Documents last October 22, 2018;

WHEREAS, a total of six (6) suppliers submitted their respective bids of which only three (3) passed the eligibility requirements, namely: D'Triumph Cleaners and Allied Services, Inc., The Perfect Cleaners Sales and Services and Starcom and Allied Services, Inc., thus their respective second envelope containing the Financial Documents were opened and the BAC endorsed the said documents to the Technical Working Group (TWG) for further evaluation.

WHEREAS, the results of the TWG Evaluation of the Financial Documents were as follows:

Prospective Bidder	Financial Proposal (PhP)	Remarks
D'Triumph Cleaners & Allied Services	1,885,689.60	Non-responsive for not complying on the supplies and materials required by PCAF, The bidder offered Metal Polish instead of Toilet Bowl Brush which to be supplied on semi annual.
The Perfect Cleaners, Sales & Services	1,885,689.60	Non-responsive for non-submission of the schedule of prices for the supplies and materials provided to PCAF
Starcom Manpower & Allied Services, Inc.	1,741,145.87	As per, Bidding Document, under Section 28: Detailed Evaluation and Comparison of Bids, stated that " <u>Bids shall be evaluated on an equal footing to ensure fair competition.</u> " Hence, the TWG recalculate the proposal based on the 10% admin. cost as stated in the Bid Form for the purpose of evaluation, thus, the amount must be PhP 1,885,689.60.


WHEREAS, the BAC upon examination of the documents had agreed with the findings of the TWG that the bids of D'Triumph Cleaners & Allied Services and the Perfect Cleaners, Sales & Services were Non-responsive as recommended by the TWG. With regards to Starcom Manpower & Allied Services, Inc., the BAC upon closer scrutiny of their submitted Financial Documents, had discovered that the bidder has not included the Estimated Cost of Supplies and Materials in the said document, as required in the Bid Form of the Bidding Documents, thus the third bidder was also declared Non-responsive;

WHEREAS, having established that the three mentioned bidders were all Non-responsive to the requirements as contained in the Bidding Documents, the BAC hereby declare a failure of bidding;


NOW THEREFORE, BE IT RESOLVED as it is hereby resolved, that the BAC recommends to the Head of the Procuring Entity (HOPE) a failure of bidding for the Procurement of One (1) Year Janitorial Services to Maintain Cleanliness and Sanitation of PCAF Offices and Its Premises (2019) and the reposting of the same as soon as possible.
