**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THE
APPROVAL OF THE NOTICE OF AWARD TO CHALI BEACH AND RESORT
CORPORATION AS HAVING SUBMITTED THE SINGLE CALCULATED AND
RESPONSIVE BID RELATIVE TO PCAF'S PROCUREMENT OF HOTEL FOOD AND
ACCOMMODATIONS FOR THE CONDUCT OF THE 2018 NATIONAL VOLUNTEERS'
DAY**

WHEREAS, the PCAF had issued an Invitation to Bid No. 2018-03 for the Procurement of Hotel Food and Accommodations for the above mentioned event to be held in Cagayan de Oro City on December 3-7, 2018.

WHEREAS, only one prospective bidder, the Chali Beach and Resort Corporation responded to the invitation and submitted a bid which was responsive to the bidding requirements;

WHEREAS, as the sole bidder, Chali Beach and Resort Corporation upon careful evaluation by the BAC-TWG has passed the eligibility, technical and financial requirements screening for having the Single Calculated Bid and subject for the submission of its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS) as a post qualification requirement;

WHEREAS, Chali Beach Resort Corporation has submitted the said document as required on time, thus, the BAC has determined that it complied with and is responsive to the requirements and conditions specified in the bidding documents and passed the criteria for post qualification and could be declared as the Single Calculated and Responsive Bid;

NOW THEREFORE, BE IT RESOLVED as it is hereby resolved, that the BAC recommends to the Head of the Procuring Entity (HOPE) to award to Chali Beach and Resort Corporation the procurement of Hotel Food and Accommodations for the Conduct of the 2018 National Volunteers' Day on December 3-7, 2018 in Cagayan de Oro City, in the amount of **Two Million Two Hundred Sixty Six Thousand Nine Hundred Fifty Pesos (PhP2,266,950.00)** as having offered the Single Calculated and Responsive Bid.


