**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THE APPROVAL OF THE NOTICE OF AWARD TO NAFC-DA MULTI-PURPOSE COOPERATIVE (NADAMCO) AS HAVING SUBMITTED THE SINGLE CALCULATED AND RESPONSIVE BID RELATIVE TO PCAF'S PROCUREMENT OF MEALS FOR THE CONDUCT OF VARIOUS MEETINGS/ACTIVITIES FOR THE 1<sup>ST</sup> QUARTER FY 2019**

**WHEREAS**, the PCAF had issued an Invitation to Bid No. 2018-07 for the Procurement of Meals for the 1<sup>st</sup> Quarter 2019 for its various meetings/activities;

**WHEREAS**, two (2) prospective bidders namely Fresh and Famous Foods, Inc. and NAFC-DA Multi-Purpose Cooperative (NADAMCO), responded to the invitation and submitted their bid documents, however only NADAMCO was responsive to the bidding requirements;

**WHEREAS**, NADAMCO upon careful evaluation by the BAC-TWG has passed the eligibility, technical and financial requirements screening for having the Single Calculated Bid and subject for the submission of its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS) as a post qualification requirement;

**WHEREAS**, NADAMCO has submitted the said document as required on time, thus, the BAC has determined that it complied with and is responsive to the requirements and conditions specified in the bidding documents and passed the criteria for post qualification and could be declared as the Single Calculated and Responsive Bid;

**NOW THEREFORE, BE IT RESOLVED** as it is hereby resolved, that the BAC recommends to the Head of the Procuring Entity (HOPE) to award to NADAMCO the said procurement in the amount of **Nine Hundred Seventy Thousand Four Hundred Thirty-Six Pesos (PhP 970,436.00)** as having offered the Single Calculated and Responsive Bid.
