**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THE
APPROVAL OF THE NOTICE OF AWARD TO MASANGKAY COMPUTER CENTER, INC.
FOR HAVING SUBMITTED THE SINGLE CALCULATED AND RESPONSIVE BID
RELATIVE TO PCAF'S PUBLIC BIDDING FOR THE PROCUREMENT OF CELL CARDS
FOR THE PERIOD JANUARY TO DECEMBER 2018**

WHEREAS, the PCAF had issued an Invitation to Bid (ITB) No. 2018-01 for the Procurement of Cell Cards for the period January to December 2018;

WHEREAS, such ITB was posted in the PhilGEPS wherein only one (1) prospective bidder namely, the Masangkay Computer Center, Inc. responded and submitted a bid within the deadline as specified in the Bidding Documents;

WHEREAS, Masangkay Computer Center, Inc. passed the initial evaluation by the BAC on the provision of the eligibility and technical requirements, hence its Financial Document was opened for evaluation of which it offered a bid of One Million One Hundred Five Thousand Two Hundred Pesos (PhP 1,105,200.00) which is within the Approved Budget for the Contract (ABC).


WHEREAS, upon careful evaluation by the BAC-TWG, Masangkay Computer Center, Inc. complied with the eligibility, technical and financial requirements screening, hence considered as having submitted the Single Calculated Bid and therefore subject for post qualification and is required to submit its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS);

WHEREAS, Masangkay Computer Center, Inc. has submitted the said document and the BAC has determined that it complied and is responsive to all the requirements and conditions specified in the bidding documents and passed the criteria for post qualification thus declared as the Single Calculated and Responsive Bid;

NOW THEREFORE, BE IT RESOLVED as it is hereby resolved, that the BAC recommends to the Head of the Procuring Entity (HOPE) to award to Masangkay Computer Center the procurement of Cell Cards for the Period January to December 2018 in the amount of **One Million One Hundred Five Thousand Two Hundred Pesos (PhP 1,105,200.00)** as having offered the Single Calculated and Responsive Bid.


