RECOMMENDING TO THE HEAD OF PROCURING ENTITY [HOPE] THE APPROVAL OF THE NOTICE OF AWARD TO CENTREX CORPORATION AS THE SUPPLIER WITH THE SINGLE CALCULATED AND RESPONSIVE BID
