

CONTRACT AGREEMENT

THIS AGREEMENT, made this 14th day of SEPTEMBER, 2017 between PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES (PCAF), Apacible Hall, Department of Agriculture Compound, Elliptical Road, Diliman, Quezon City hereinafter called the "Entity" and SOUTHEAST ASIAN REGIONAL CENTER FOR GRADUATE STUDY AND RESEARCH IN AGRICULTURE (SEARCA), College, Los Baños, Laguna 4031, hereinafter called the "Consultant").

WHEREAS, the Entity is desirous that the Consultant execute Consultancy Services for the Conduct of Evaluative Study Entitled "Intensive Use of Mechanized Technology in Agriculture Sector: An Evaluation of the Effects and Implications in Selected Commodity Value Chains" hereinafter called "the Works" and the Entity has accepted the bid for **Eight Million Nine Hundred Ninety-Six Thousand Nine Hundred Seventy-Eight Pesos (PhP8,996,978.00)** by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - (c) Request for Expression of Interest;
 - (d) Instructions to Bidders;
 - (e) Bid Data Sheet;
 - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (h) Eligibility requirements, documents and/or statements;
 - (i) Performance Security;
 - (j) Notice of Award of Contract and the Bidder's conforme thereto;
 - (k) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.




