**RECOMMENDING TO THE HEAD OF PROCURING ENTITY [HOPE] THE APPROVAL OF  
THE NOTICE OF AWARD TO DESIGN CREST FURNITURE AS THE  
SUPPLIER WITH THE LOWEST CALCULATED RESPONSIVE BID**

**WHEREAS**, the procurement of 7 pcs. Filing/Storage Cabinet for PDCD's use was undertaken as prescribed in Section 53.9 Negotiated Procurement- Small Value Procurement of the 2016 Revised IRR of R.A. 9184;

**WHEREAS**, the Request for Quotation indicating the specifications, quantity and ABC for the above mentioned procurement was advertised in the PhilGEPS on August 24-30, 2017 where interested suppliers submitted sealed quotations with the following details:

WHEREAS, the lowest bidder; **SEE MANUFACTURING CONTRACTOR** did not comply with the PCAF specifications in terms of color and is therefore not responsive;


WHEREAS, the bids of **IKF HOME FURNISHING AND OFFICE FURNITURE, MAGNETO ENTERPRISE** and **WORKSTATION DESIGNERS CENTER** were all evaluated to be above the Approved Budget for the Contract and are considered not responsive;

WHEREAS, the second lowest bidder; **DESIGN CREST FURNITURE** complied with the PCAF specifications, submitted Certificate of PhilGEPS registration and is within the ABC, thus, was considered the Lowest Calculated Responsive Bid;

WHEREFORE, **RESOLVED AS IT IS HEREBY RESOLVED**, that we, the members of the BAC, recommend to the HOPE to award the said procurement to **DESIGN CREST FURNITURE** in the amount of **PhP 52,500.00** being the Lowest Calculated Responsive Bid.


