**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THE
APPROVAL OF THE NOTICE OF AWARD TO JONECO TECH. MARKETING CORP.
FOR THE PROCUREMENT OF ICT EQUIPMENT
(LOT 2: 48 UNITS DESKTOP)**

WHEREAS, it is a paramount commitment of the Government of the Philippines (GOP) to promote good governance and to adhere to the principles of transparency, accountability, equity, efficiency and economy in its procurement process;

WHEREAS, the PCAF through the General Appropriations Act (GAA) of 2019 intends to apply a total of Five Million Seven Hundred Fifty Thousand Pesos (PhP 5,750,000.00) being the Approved Budget for the Contract (ABC), for the procurement of the following ICT Equipment on a per lot basis as follows:

1. Lot 1 : 67 units laptop (ABC : PhP 3,350,000.00)
2. Lot 2 : 48 units Desktop Computer (ABC : PhP 2,400,000.00)

WHEREAS, an Invitation to Bid No. 2018-05 was issued for the procurement of the above ICT Equipment through Early Procurement and the corresponding Bidding Documents prepared and made available at a cost to interested bidders;

WHEREAS, last December 26, 2018, four (4) suppliers namely Unison Computer System, Inc., S1 Technologies, Inc., Tekzone Computer Sales & Services, Inc and Joneco Tech Marketing Corp. submitted their respective bid documents and all of the four (4) passed the eligibility requirements, thus their respective second envelope containing the Financial Documents were opened wherein all four quoted only for Lot 2- 48 units Desktop Computer and none for Lot 1 - 67 units Laptop. The Abstract of Bids was prepared and signed by the previous BAC at that time. The BAC then endorsed the submitted documents to the Technical Working Group (TWG) for further evaluation for Lot 2 and declared a failure of bidding for Lot 1;

WHEREAS, Joneco Tech Marketing Corp., upon careful evaluation by the BAC-TWG has passed the eligibility, technical and financial requirements screening for having the Lowest Calculated Bid and subject for the submission of its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS) as a post qualification requirement;

WHEREAS, Joneco Tech Marketing Corp., submitted the said document as required on time, thus, the BAC determined that it complied with and is responsive to the requirements and conditions specified in the bidding documents and passed the criteria for post qualification and could be declared as the Lowest Calculated and Responsive Bid;

NOW THEREFORE, BE IT RESOLVED as it is hereby resolved, that the BAC recommends to the Head of the Procuring Entity (HOPE) to award to Joneco Tech Marketing Corp., the said procurement in the amount of **One Million Nine Hundred Eleven Thousand Seven**

Hundred Ninety-Two Pesos (PhP1,911,792.00) as having offered the Lowest Calculated and Responsive Bid.
