RECOMMENDING TO THE HEAD OF PROCURING ENTITY [HOPE] TO DECLARE FIRST FAILURE OF THE BIDDING FOR THE PROCUREMENT OF THE SUPPLY AND DELIVERY OF 4,210 PIECES OF CELLCARDS PURCHASE REQUEST NO 22-03-092

WHEREAS, the Philippine Council for Agriculture and Fisheries (PCAF) posted Invitation to Bid (ITB) No. 2022-03 with an Approved Budget for the Contract (ABC) **One Million Three Hundred Six Thousand Two Hundred Pesos Only (Php 1,306,200.00)**, at the Philippine Government Electronic Procurement System (PhilGEPs) on March 17, 2022. The said invitation to bid was also posted in the PCAF website, and at conspicuous places within/near the premises of the PCAF from March 17 to April 7, 2022;

WHEREAS, the pre-bid and the opening of bid/s for the said procurement project was conducted on March 25, 2022 and April 7, 2022, respectively in a face-to-face meeting at the Conference room of the office of the AFMD Division Chief, PCAF Apacible Hall, DA Compound, Elliptical Road, Diliman, Quezon City;

WHEREAS, since there were no submission of bid/s from the bidder/s on the set deadline, the members of the BAC declared the failure of the bidding for the procurement of the supply and delivery of 4,210 pieces of cellcards;

WHEREAS, Section 35.a of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, provides that the BAC shall declare the bidding a failure when **"no bids are received"**;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that we, the members of the BAC, recommend to the HOPE the following:

1. To declare the first failure of competitive bidding conducted for ITB No. 2022-03 for non-submission of bid/s from the prospective bidder/s; and
2. To conduct a re-bidding with re-advertisement and/or posting as provided for in Section 21.2 of the 2016 Revised IRR of R.A. No. 9184.






