**RECOMMENDING TO THE HEAD OF PROCURING ENTITY [HOPE] THE APPROVAL OF
THE NOTICE OF AWARD TO MASANGKAY COMPUTER CENTER. FOR THE SUPPLY
AND DELIVERY OF 4,210 PCS OF CELLCARDS UNDER PURCHASE REQUEST
NO. 22-03-092**

WHEREAS, the Philippine Council for Agriculture and Fisheries (PCAF) intends to procure 4,210 pieces of cellcards with an Approved Budget for the Contract (ABC) amounting to **One Million Three Hundred Six Thousand Two Hundred Pesos (Php 1,306,200.00)**

WHEREAS, the Bids and Awards Committee (BAC) declared the first failed bidding under BAC Resolution No.2022-042 dated April 07, 2022, hence, the Invitation to Bid (ITB) No. 2022-03 was reposted in the Philippine Government Electronic Procurement System (PhilGEPS) website on June 16, 2022 in accordance with Section 21.2 of the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, on July 05, 2022, 10:00 a.m, the deadline for the submission and receipt of bids, there were no bids received, thus, the members of the BAC declared a second failure of bidding as stated in Section 35.1.a of the 2016 Revised IRR of RA 9184, that the BAC shall declare the bidding a failure when **"no bids are received"**;

WHEREAS, the PCAF decided to resort to Negotiated Procurement as provided for in Section 53.1 of the 2016 Revised IRR of RA 9184.

WHEREAS, the Requests for Financial Proposal indicating the specifications, quantity and ABC for the above-mentioned procurement based on PR No. 22-03-092 was posted in the PHILGEPS from July 28, 2022 to August 09, 2022;

WHEREAS, on **August 12, 2022**, the scheduled opening of the bid was undertaken by the BAC in compliance to Section 53.1 Negotiated Procurement - Two Failed Biddings of 2016 Revised IRR of R.A. 9184, there were three (3) bidders that responded and submitted their bids namely: **MASANGKAY COMPUTER CENTER, GOLD INTERNATIONAL TRADING, and MPOWER SERVICES SOLUTION INC.**;

WHEREAS, the members of the BAC evaluated the submitted proposals from the three (3) bidders and found out that **MASANGKAY COMPUTER CENTER.** was the lowest calculated and responsive bid (*please refer to Annex A - Abstract of Quotation*);

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that we, the members of the BAC, recommend to the Head of Procuring Entity (HOPE) to award the procurement of **4,210 pcs of Cell Cards** to **MASANGKAY COMPUTER CENTER.**, in the total amount of **One Million Three Hundred Six Thousand Two Hundred Pesos (Php 1,306,200.00)** being the Lowest Calculated and Responsive Bid;
