RECOMMENDING TO THE HEAD OF PROCURING ENTITY [HOPE] THE APPROVAL OF THE NOTICE OF AWARD TO NADAMCO FOR THE PROCUREMENT OF ONE (1) LOT MEALS FOR THE CONDUCT OF PCAF VARIOUS MEETINGS/ACTIVITIES FOR JANUARY TO DECEMBER 2023 UNDER PURCHASE REQUEST NO. 22-10-137

WHEREAS, the Philippine Council for Agriculture and Fisheries (PCAF) posted Invitation to Bid (ITB) No. 2022-06 for the procurement of **One (1) Lot Meals for the conduct of PCAF various meetings/activities for January to December 2023** with an Approved Budget for the Contract (ABC) of **Four Million Four Hundred Eighty-Eight Thousand Seven Hundred Forty-Four Pesos and Twenty-Four Centavos (Php4,488,744.24)**, at the Philippine Government Electronic Procurement System (PhilGEPS), PCAF website, and at conspicuous places within/near the premises of the PCAF from November 21 to December 12, 2022;

WHEREAS, the Procurement Project is composed of one (1) lot, the details of which are described in Section VII (Technical Specifications) of the Bidding Documents;

WHEREAS, the Pre-Bid Conference was conducted on November 28, 2022 at the AFMD Chief Discussion Area 2nd Floor PCAF Building, DA Compound, Elliptical Road, Diliman, Quezon City;

WHEREAS, only (1) bidder which is the **NAFC-DA Multi-Purpose Cooperative (NADAMCO)**, responded to the invitation and submitted its bid through the BAC Secretariat on the set deadline which was opened during the Bid Opening on December 12, 2022;

WHEREAS, during the opening and preliminary examination of the bids on December 12, 2022, the BAC checked the technical and financial component envelopes submitted by **NADAMCO** in accordance with Section 30 of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. No. 9184;

WHEREAS, the BAC ascertained, using a checklist, if all the required documents are present in the technical and financial component envelopes submitted by the bidder, using a non-discretionary "pass/fail" criterion;

WHEREAS, the technical and financial component envelopes of the **NADAMCO** were found to include all the required documents, thus, were rated as "passed" and were then forwarded to the BAC-Technical Working Group (TWG) for the detailed evaluation of the bid;

WHEREAS, the bid of **NADAMCO**, upon careful evaluation by the BAC-TWG, has passed the eligibility, technical, and financial requirements screening, having the Single Calculated Bid (SCB), thus was required to submit their latest income and business tax returns filed with the BIR and paid through the BIR Electronic Filing and Payment System (eFPS) and other appropriate licenses and permits required by law as stated in the Bid Data Sheet (BDS) as a requirement for post qualification;

WHEREAS, the results of the bid evaluation and post qualification evaluation by the BAC-TWG for **NADAMCO** are as follows:

- Based on the submitted documents, **NAFC-DA Multi-Purpose Cooperative (NADAMCO)** is the lone bidder, with PhilGEPS Platinum membership, did not exceed the total amount of ABC, has updated permit to operate from the Mayor's Office, and employees are with health certificate;
- **NADAMCO** is not included in the blacklisted entities of the Government Procurement Policy Board (GPPB);
- The TWG conducted an ocular inspection of the premises of **NADAMCO**, and ascertained the satisfactory cleanliness of the area and equipment, accessibility, safety, good value for money, and location, thus, and the TWG deemed the bidder suitable for the requested procurement;




WHEREAS, the BAC-TWG has recommended the award of the contract to **NADAMCO**, being the single calculated bid and complied with the agency requirements in the amount of **Four Million One Hundred Sixty-Seven Thousand One Hundred Fifty Pesos (Php 4,167,150.00)**;

WHEREAS, after deliberation, the BAC has concurred with the recommendation of the BAC-TWG;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that we, the members of the BAC, recommend to the Head of Procuring Entity (HOPE) to award the procurement of **ONE (1) LOT MEALS FOR THE CONDUCT OF PCAF VARIOUS MEETINGS/ACTIVITIES FOR JANUARY TO DECEMBER 2023** to **NADAMCO** in the total amount of **FOUR MILLION ONE HUNDRED SIXTY-SEVEN THOUSAND ONE HUNDRED FIFTY PESOS (Php 4,167,150.00)** being the Single Calculated and Responsive Bid;
