**RECOMMENDING TO THE HEAD OF PROCURING ENTITY [HOPE] TO DECLARE
SECOND (2ND) FAILURE OF BIDDING FOR THE PROCUREMENT OF 3,400 PCS OF
CELLCARDS FOR FY 2023 UNDER PURCHASE REQUEST NO. 22-11-166
AND RESORT TO NEGOTIATED PROCUREMENT**

WHEREAS, the Philippine Council for Agriculture and Fisheries (PCAF) intends to procure **3,400 pcs of Cell Cards for FY 2023** with an Approved Budget for the Contract (ABC) of **One Million Fifty-Three Thousand Six Hundred Pesos (Php1,053,600.00)**;

WHEREAS, the Bids and Awards Committee (BAC) declared a first failed bidding under BAC Resolution No. 2022 - 223 dated December 19, 2022;

WHEREAS, the PCAF reposted the Invitation to Bid (ITB) No. 2022-07 for the supply and delivery of 3,400 pieces of cellcards for FY 2023 in the Philippine Government Electronic Procurement System (PhilGEPS) website on December 23, 2022 in accordance with Section 21.2 of the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, the Pre-Bid Conference was conducted on January 06, 2023 at the AFMD Chief Discussion Area 2nd Floor PCAF Building, DA Compound, Elliptical Road, Diliman, Quezon City, and on January 18, 2023, the scheduled Bid Opening was also done at the AFMD Chief Discussion Area 2nd Floor PCAF Building, DA Compound, Elliptical Road, Diliman, Quezon City;

WHEREAS, there were no submission of bid/s from the bidder/s on the set deadline, thus, the members of the Bids and Awards Committee (BAC) declared the second failure of bidding for the procurement of 3,400 pcs of Cellcards for FY 2023;

WHEREAS, as stated in Section 35.1.a of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, the BAC shall declare the bidding a failure when **"no bids are received"**;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that we, the members of the BAC, recommend to the Head of Procuring Entity (HOPE) the following:

1. To declare the second failure of competitive bidding conducted for ITB No. 2022-07 for non-submission of bid/s from the prospective bidder/s; and
2. To resort to Negotiated Procurement as provided for in Section 53.1 of the 2016 Revised IRR of RA 9184.
