**WHEREAS**, the Requests for Quotations (RFQs) indicating the specifications, quantity, and Approved Budget for the Contract (ABC) for the above-mentioned procurement based on PR No. 22-10-175 was posted in the PHILGEPS from Dec. 12 to Dec. 16, 2022;

**WHEREAS, on December 16, 2022**, the scheduled opening of the bid was undertaken by the Bids and Awards Committee (BAC) in compliance with Section 53.9 Negotiated Procurement - Small Value Procurement of 2016 Revised IRR of R.A. 9184, there were three (3) bidders that responded and submitted their bids namely: **NEOTECH ASIA DISTRIBUTION, MYBUSYBEE INC, AND DATA CORE TECHNOLOGIES;**

**WHEREAS**, the members of the Bids and Awards Committee (BAC) evaluated the submitted proposal from the three (3) bidders and found out that **DATA CORE TECHNOLOGIES** was the lowest calculated and responsive quotation (*please refer to Annex A - Abstract of Quotation*);

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, that we, the members of the BAC, recommend to the Head of Procuring Entity (HOPE) to award the procurement of **ONE (1) LOT ONE (1) YEAR SOFTWARE SUBSCRIPTION OF ELEVEN (11) ZOOM BUSINESS LICENSES FOR FY 2023** to **DATA CORE TECHNOLOGIES**, in the total amount of **ONE HUNDRED TWENTY-ONE THOUSAND PESOS (Php 121,000.00)** being the Lowest Calculated and Responsive Quotation;
