RECOMMENDING TO THE HEAD OF PROCURING ENTITY [HOPE] THE APPROVAL OF THE NOTICE OF AWARD TO TRIPLE 7 MANPOWER SERVICES INC FOR THE PROCUREMENT OF ONE (1) LOT ONE (1) YEAR JANITORIAL SERVICES TO MAINTAIN CLEANLINESS AND SANITATION OF PCAF OFFICES AND PREMISES (FY 2023) UNDER PURCHASE REQUEST NO. 22-09-030

WHEREAS, the Philippine Council for Agriculture and Fisheries (PCAF) posted Invitation to Bid (ITB) No. 2022-05 for the procurement of **One (1) Lot One (1) Year Janitorial Services to maintain cleanliness and sanitation of PCAF offices and premises (FY 2023)** with an Approved Budget for the Contract (ABC) of **Two Million Four Hundred Ninety-Nine Thousand One Hundred Sixty-Four Pesos and Sixteen Centavos (Php2,499,164.16)**, at the Philippine Government Electronic Procurement System (PhilGEPS), PCAF website, and at conspicuous places within/near the premises of the PCAF from November 21 to December 12, 2022;

WHEREAS, the Procurement Project is composed of one (1) lot, the details of which are described in Section VII (Technical Specifications) of the Bidding Documents;

WHEREAS, the Pre-Bid Conference was conducted on November 28, 2022 at the AFMD Chief Discussion Area 2nd Floor PCAF Building, DA Compound, Elliptical Road, Diliman, Quezon City;

WHEREAS, there were two (2) bidders namely: **D'TRIUMPH CLEANERS AND ALLIED SERVICES INCS, AND TRIPLE 7 MANPOWER SERVICES INC.** that responded to the invitation and submitted their bids through the BAC Secretariat on the set deadline which was opened during the Bid Opening on December 12, 2022;

WHEREAS, during the opening and preliminary examination of the bids on December 12, 2022, the BAC checked the technical and financial component envelopes submitted by the two (2) bidders: **D'TRIUMPH CLEANERS AND ALLIED SERVICES INCS, AND TRIPLE 7 MANPOWER SERVICES INC** in accordance with Section 30 of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. No. 9184;

WHEREAS, the BAC ascertained, using a checklist, if all the required documents are present in the technical and financial component envelopes submitted by the bidders using a non-discretionary "pass/fail" criterion;

WHEREAS, the technical and financial component envelopes of the two (2) bidders: **D'TRIUMPH CLEANERS AND ALLIED SERVICES INCS, AND TRIPLE 7 MANPOWER SERVICES INC**; were found to include all the required documents, thus, were rated as "passed" and were then forwarded to the BAC-Technical Working Group (TWG) for further evaluation of the bids;

WHEREAS, after the evaluation of the submitted bids, the BAC-TWG submitted the following findings:

- PR No. 22-09-030 for the one (1) Lot/One Year Janitorial Services to maintain cleanliness and sanitation of PCAF offices and premises (FY 2023);
- 1.1 Two (2) entities submitted bids for the abovementioned Purchase Request, namely; **D'Triumph Cleaners and Allied Services, Inc,** and **Triple 7 Manpower Services, Inc.;**
- 1.2. Based on the documents forwarded by the BAC Secretariat, both bidders are within ABC of **Two Million Four Hundred Ninety-Nine Thousand One Hundred Sixty-Four Pesos and Sixteen Centavos (Php 2,499,164.16);**



1.3. Both bidders have PhilGEPS Platinum membership and have complied with the complete and correct computation of the minimum daily basic wage, and mandatory contributions, such as: SSS, PhilHealth, Pagibig etc. Remittances for the aforementioned mandatory payables to the government were also validated to be updated;

1.4. Both entities are not included in the GPPB list of blacklisted organizations;

WHEREAS, after the results of the bid evaluation by the BAC-TWG, it was found out that **TRIPLE 7 MANPOWER SERVICES INC.** had the Lowest Calculated Bid (LCB), thus was required to submit their latest income and business tax returns filed with the BIR and paid through the BIR Electronic Filing and Payment System (eFPS) and other appropriate licenses and permits required by law as stated in the Bid Data Sheet (BDS) as a requirement for post qualification;

WHEREAS, the BAC-TWG has recommended the award of the contract to **TRIPLE 7 MANPOWER SERVICES INC** being the lowest calculated bid and complied with the agency requirements in the amount of **Two Million Three Hundred Seventy-One Thousand Eight Hundred Fifty-Four Pesos and Seventy-Two Centavos (Php 2,371,854.72)**;

WHEREAS, the BAC has concurred with the results of the BAC-TWG evaluation and agreed to award the contract to **TRIPLE 7 MANPOWER SERVICES INC**, for having passed the criteria for post evaluation, had complied and was responsive to the requirements and conditions specified in the Bidding Documents and thus be declared as the Lowest Calculated and Responsive Bid (LCRB);

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that we, the members of the BAC, recommend to the Head of Procuring Entity (HOPE) to award the procurement of **ONE (1) LOT ONE (1) YEAR JANITORIAL SERVICES TO MAINTAIN CLEANLINESS AND SANITATION OF PCAF OFFICES AND PREMISES (FY 2023)** to **TRIPLE 7 MANPOWER SERVICES INC** in the total amount of **TWO MILLION THREE HUNDRED SEVENTY-ONE THOUSAND EIGHT HUNDRED FIFTY-FOUR PESOS AND SEVENTY-TWO CENTAVOS (Php 2,371,854.72)** being the Lowest Calculated and Responsive Bid;
