## CONTRACT OF AGREEMENT

KNOW ALL MEN BY THESE PRESENT:

This Contract of Agreement made and entered into this **JAN 16 2023** day of \_\_\_\_\_ 2023 at Quezon City, Philippines by and between:

The **PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES (PCAF)**, a government agency attached to the Department of Agriculture (DA), created pursuant to Executive Order No. 366, Series of 2004, and the Department of Budget and Management (DBM) approved Rationalization Plan covering the consolidation of the National Agricultural and Fishery Council (NAFC) and Livestock Development Council (LDC) on June 26, 2013, with office address at the Apacible Hall, Department of Agriculture Compound, Elliptical Road, Diliman, Quezon City, represented in this Act by its **Executive Director III, NESTOR D. DOMENDEN, CESO IV**, hereinafter referred to as the **PCAF**;

-and-

**DATA CORE TECHNOLOGIES**, a company licensed to operate business under the laws of the Republic of the Philippines with principal office address at 195 Carriedo St., Tibagan, San Juan City, represented in this Act by its **Business Dev Officer, CHRISTINE CONSUL**, hereinafter referred to as the **SUPPLIER**;

### WITNESSETH

**WHEREAS**, the **PCAF** requested the procurement of one (1) lot one (1) year software subscription of eleven (11) zoom business licenses for FY 2023 through PR No. 22-11-175 and was posted in the PhilGEPS for bidding;

**WHEREAS**, the **SUPPLIER** is engaged in the supply and delivery of zoom business meeting license subscription and had submitted its quotation;

**WHEREAS**, after due evaluation by the Bids and Awards Committee (BAC), the **SUPPLIER** was declared as the Lowest Calculated and Responsive Bid, thus, the BAC recommended to the HOPE to award the above-mentioned procurement to the **SUPPLIER**;

**WHEREAS**, **PCAF** issued the Notice of Award to the **SUPPLIER** on December 28, 2022;

**NOW THEREFORE**, in view of the foregoing premises, the parties have agreed to these following terms and conditions:

#### A. OBLIGATIONS OF PCAF

1. Allocate and disburse funds in the total amount of **ONE HUNDRED TWENTY-ONE THOUSAND PESOS (Php 121,000.00)** to **DATA CORE TECHNOLOGIES** for the procurement of one (1) lot one (1) year software subscription of eleven (11) zoom business licenses for FY 2023; and
2. Pay the **SUPPLIER** after completion of the deliverables and receipt of the billing statement;
3. Agrees to strictly follow the **SUPPLIER'S** protocols and standard procedures; and
4. Provide a representative available for the details of the zoom license.

- Mobile, desktop, conference rooms supported
- Up to 300 video participants per host
- Local and Cloud recording with transcripts (up to 1GB)
- Multi-screening sharing, co-annotation, remote control
- Play video with audio
- Dual camera for video sharing, dual monitor for screen sharing
- With breakout rooms and waiting rooms

- **Chat**

- Text, image and audio file sending across desktop, laptop, tablets and mobile
- Availability status, both desktop and mobile
- Content library for easy sharing
- Group creation for faster collaboration

- **Support**

- Technical Support thru ticket, chat or phone
- With reporting user management, admin portal and managed domain features

- **Others**

- Assist the PCAF in the overall deployment of the Zoom License
- Provide support whenever PCAF has concerns and inquiries
- List and details of phone and email support, for point of contact of PCAF employees

2. Submit Proof of Entitlement (POE) or document for Zoom Business Subscription Contract;

3. Bill the **PCAF** for the zoom business meeting license subscription; and

4. Acknowledge the receipt of payment by issuing an Official Receipt in the name of the **PCAF**.




