

CONTRACT OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Agreement made executed and entered into for all intents and all respects at QUEZON CITY on this JUN 07 2022 day of 2022, 2022 by and between:

The **Philippine Council for Agriculture and Fisheries (PCAF)**, with principal office address at DA Compound, Apacible Building, Elliptical Road, Diliman, Quezon City, represented by OIC Executive Director Liza G. Battad, Ph.D., hereinafter referred to as the **ENTITY**;

AND

The **Quartz Business Products Corporation**, with business address at 15th Capitol House 9th Avenue Corner 34th Street Bonifacio Global City Fort Bonifacio, Taguig City, represented by Ms. Jervin F. Puso, Account Manager, hereinafter referred to as the **SUPPLIER**;

WHEREAS, the first party invited bids for certain goods and ancillary services, particularly for the Supply and Delivery of 50 Units Laptop Computer and has accepted a bid by the Supplier for the supply of those goods and services in the sum of **Three Million One Hundred Twenty-Five Thousand Eight Hundred Fifty Pesos Only (PhP 3,125,850.00)** hereinafter called as the "Contract Price";

NOW THESE AGREEMENT WITNESSETH AS FOLLOW:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to;
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz:

- i. Philippine Bidding Documents (PBDs);
 - Schedule of Requirements;
 - Technical Specifications;
 - General and Special Conditions of Contract; and
 - Supplemental and Bid Bulletin, if any
- ii. Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statement submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidders response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **Three Million Three One Hundred Twenty-Five Thousand Eight Hundred Fifty Pesos Only (PhP 3,125,850.00)**, or such other sums as may be ascertained, Supplier agrees for the Supply and Delivery of 50 Units Laptop computer in accordance with its Bid;
4. The PCAF agrees to pay the above-mentioned sum in accordance with the terms of the Bidding;


