CONTRACT OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This **Contract** made and executed this MAY 05 2022 2022, in Quezon City, Philippines, by and between: **the Philippine Council for Agriculture and Fisheries (PCAF)** herein referred to as the first party and the **NAFC-DA Multi- Purpose Cooperative (NADAMCO)** herein referred to as the second party;

WHEREAS, the first party invited bids for certain goods and ancillary services, particularly for the procurement of One (1) Lot Meals for the Conduct of Various Meetings/Activities of PCAF from May to December 2022 and has accepted a bid by the second party for the supply of those goods and services in the sum of **Four Million Fourteen Thousand Six Hundred Pesos Only (PhP 4,014,600.00)** hereinafter called as the "Contract Price".

NOW THESE AGREEMENT WITNESSETH AS FOLLOW:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to;
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz:

i. Philippine Bidding Documents (PBDs);

- Schedule of Requirements;
- Technical Specifications;
- General and Special Conditions of Contract; and
- Supplemental and Bid Bulletin, if any

ii. Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statement submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidders response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring entity's bid evaluation;


iii. Performance Security;


iv. Notice of Award of contract; and the Bidder's conforme thereto: and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.


3. In consideration for the sum of **Four Million Fourteen Thousand Six Hundred Pesos Only (PhP 4,014,600.00)**, or such other sums as may be ascertained, NADAMCO agrees to provide and serve One Lot Meals for the conduct of various meetings/activities of PCAF from May 1 to December 31, 2022 in accordance with its Bid;
4. The PCAF agrees to pay the above-mentioned sum in accordance with the terms of the Bidding

IN WITNESS, WHEREOF, the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


