

**CONTRACT OF AGREEMENT**

**KNOW ALL MEN BY THESE PRESENT:**

19 SEP 2023

This Contract of Agreement made and entered into this \_\_\_\_ day of September 2023 at Quezon City, Philippines by and between:

The **PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES (PCAF)**, a government agency attached to the Department of Agriculture (DA), created pursuant to Executive Order No. 366, Series of 2004, and the Department of Budget and Management (DBM) approved Rationalization Plan covering the consolidation of the National Agricultural and Fishery Council (NAFC) and Livestock Development Council (LDC) on June 26, 2013, with office address at the Apacible Hall, Department of Agriculture Compound, Elliptical Road, Diliman, Quezon City, represented in this Act by its **OIC-Executive Director, JULIETA E. OPULENCIA**, hereinafter referred to as the **PCAF**;

-and-

**EON CENTENNIAL RESORT HOTEL & WATER PARK**, a company licensed to operate business under the laws of the Republic of the Philippines with principal office address at Alta Tierra Village, Jaro, Iloilo City represented in this Act by its **Operations Manager, MA. ALANA B. CAMBAYA**, hereinafter referred to as the **SUPPLIER**.

**WHEREAS, the PCAF** requested the procurement of one (1) lot food and accommodation for the **Conduct of FY 2023 Visayas Participatory Performance Review and Planning Workshop on October 17-20, 2023** with approved PR No. 23-08-375 and was posted in the PhilGEPS for bidding;

**WHEREAS, the SUPPLIER** is engaged in meals and accommodation services and had submitted its quotation;

**WHEREAS, the opening of bid** was undertaken on August 31, 2023 and after due evaluation by the Bids and Awards Committee (BAC), the **SUPPLIER** was declared as Single Calculated and Responsive Bid, thus, the BAC recommended to the HOPE to award the above mentioned procurement to the **SUPPLIER**;

**WHEREAS, PCAF** issued the Notice of Award to the **SUPPLIER** on August 31, 2023;

**NOW THEREFORE**, in view of the foregoing premises, the parties have agreed to the following terms and conditions:

**A. OBLIGATIONS OF PCAF**

1. Allocate and disburse funds in the total amount of **Five Hundred Forty-Six Thousand and One Hundred Pesos Only (Php 546,100.00)** to **EON CENTENNIAL RESORT HOTEL & WATER PARK** for the procurement of one (1) lot food and accommodation for the conduct of FY2023 Visayas Participatory Performance Review and Planning Workshop on October 17-20, 2023 in Iloilo City; and
2. Pay the **SUPPLIER** after completion of the activity and receipt of the billing statement.

**B. OBLIGATIONS OF THE SUPPLIER**

1. Provide the required food and accommodation services for the conduct of the workshop on October 17-20, 2023 for the total amount of **Five Hundred Forty-Six Thousand and One Hundred Pesos Only (Php 546,100.00)**, as follows:

**Food and Accommodation:**

- 4 days and 3 nights for 86 participants
- Evening session for 86 participants

**Inclusions:**

- **HOTEL ROOM ACCOMMODATION** (2) single rooms, (28) triple sharing rooms (separate beds)
- **MEALS** on the 1st day (Managed Buffet Lunch, PM Snacks, and Managed Buffet Dinner)
- **MEALS** on the 2nd day (Breakfast, AM Snacks, Managed Buffet Lunch, PM Snacks, Managed Buffet Dinner)
- **MEALS** on the 3rd day (Buffet Breakfast, AM Snacks, Buffet Lunch, PM Snacks, Buffet Dinner/Evening Session)
- **MEALS** on the 4th day (Breakfast and AM Snacks)
- **MEALS** should include two (2) main courses, vegetables, soup, dessert, and 1 round juice during lunch and dinner

**NOTE:** No cream dory in the menu

- Free use of function room for 4 days and 1 evening session
- Provision of LCD projector and screen, whiteboard with marker and eraser, pads and pencil
- Free use of electricity for laptops and printers
- Free use of Sound System
- Flowing coffee/tea and purified water, candies and mints during sessions
- With complimentary welcome streamer and backdrop tarp
- Complimentary in-room WIFI connectivity to all rooms and conference room and access to other hotel amenities free of charge.
- Standby generator
- Free parking

2. Bill the **PCAF** for the food and accommodation services; and
3. Acknowledge the receipt of payment by issuing an Official Receipt in the name of the **PCAF**.

**C. GENERAL PROVISIONS**

The parties shall mutually agree to perform, fulfill, and abide with all the provisions and requirements, and on all matters contained or could be reasonably inferred from the Contract.


**D. AMENDMENT**

All stipulations set forth in this Contract shall apply unconditionally, subject to amendments that may be mutually agreed by both parties in writing.
