

**TRANSPORTATION CONTRACT**

KNOW ALL MEN BY THESE PRESENTS:

This Agreement made this 13 SEP 2023 day of September, 2023 by and between:

**PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES**, a government entity with office address at Apacible Hall, Department of Agriculture Compound, Elliptical Road, Diliman, Quezon City, and represented herein by its OIC-Executive Director, **JULIETA E. OPULENCIA**, hereinafter called as the **CLIENT**;

- and -

**ISLAND DRAGON TRANSPORT AND TRAVEL SERVICES, INC.**, a corporation duly organized and existing under and by the virtue of the laws of the Philippines with office address at 65 F Balagtas St. Parang, Marikina City and represented herein by its Corporate Secretary, **Yasmin Ednilag**, hereinafter called as the **SUPPLIER**;

**WITNESSETH:**

The **SUPPLIER** and **CLIENT**, in consideration of the mutual covenant and agreement herein, by one to the other, by these presents, enter into a contract of service, Whereby **SUPPLIER** shall provide transportation services to the **CLIENT** under the following terms and conditions:

1. That, the **SUPPLIER** shall provide the **CLIENT** two (2) 49-seater Air-conditioned Bus with TV, DVD Player and PA System;
2. That, the **SUPPLIER** shall provide the **CLIENT** transportation services on the following scheduled dates, as follows:  

September 18, 2023 - PCAF, Quezon City to Malvar, Batangas  
September 20, 2023 - Malvar, Batangas to PCAF, Quezon City
3. That, the **SUPPLIER** shall pay for and defray, at its own expense, the consumption of diesel, toll fees, government taxes, and driver's fee and food;
4. That, for the use of the transportation services, the **CLIENT** shall pay the **SUPPLIER**, the amount of **EIGHTY THOUSAND PESOS (P80,000.00)**;
5. That, the total contract price of **EIGHTY THOUSAND PESOS (P80,000.00)** shall be due and payable after the trip;
6. That, each passenger boarding the bus, maximum of 49, is covered with a P50,000.00/pax add-on accident insurance;
7. That, any and all violation of the conditions of this contract shall subject the guilty party to the payment damages, aside from the cost of suit and attorney's fees.


