

TRANSPORTATION CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

12 MAY 2023

This Agreement made this _____ day of May, 2023 by and between:

PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES, a government entity with office address at Apacible Hall, Department of Agriculture Compound, Elliptical Road, Diliman, Quezon City, and represented herein by its Executive Director, **NESTOR D. DOMENDEN**, hereinafter called as the **CLIENT**;

- and -

MAYNILAD TOURS & EDUCATIONAL SERVICES INC., a corporation duly organized and existing under and by the virtue of the laws of the Philippines with office address at Blk 113, Lot 25, Neopolitan Villa, Vienna Subd., Brgy. Greater Lagro, Quezon City and represented herein by its Office Manager, **ERLINDA F. VILLANUEVA**, hereinafter called as the **SUPPLIER**;

WITNESSETH:

The **SUPPLIER** and **CLIENT**, in consideration of the mutual covenant and agreement herein, by one to the other, by these presents, enter into a contract of service, Whereby **SUPPLIER** shall provide transportation services to the **CLIENT** under the following terms and conditions:

1. That, the **SUPPLIER** shall provide the **CLIENT** one (1) 49-seater air-conditioned bus with TC, DVD Player and PA System;
2. That, the **SUPPLIER** shall provide the **CLIENT** transportation services on the following scheduled dates, as follows:

May 17, 2023 -	PCAF, Quezon City to Malvar, Batangas
May 19, 2023	- Malvar, Batangas to PCAF, Quezon City

3. That, the **SUPPLIER** shall pay for and defray, at its own expense, the consumption of diesel, toll fees, government taxes, and driver's fee and food;
4. That, for the use of the transportation services, the **CLIENT** shall pay the **SUPPLIER**, the amount of **FORTY FIVE THOUSAND PESOS (P45,000.00)**;
5. That, the total contract price of **FORTY FIVE THOUSAND PESOS (P45,000.00)** shall be due and payable after the trip;
6. That, each passenger boarding the bus, maximum of 49, is covered with a P50,000.00/pax add-on accident insurance;
7. That, any and all violation of the conditions of this contract shall subject the guilty party to the payment damages, aside from the cost of suit and attorney's fees.





