



PUBLIC EXHIBITION AGREEMENT

This public exhibition agreement (the "Agreement") made this 29 NOV 2023 day of November, 2023 by and between:

and

EDUKSINE PRODUCTION CORPORATION
Represented by MR. GALO Q. MACUA
SALES HEAD / CO FOUNDER

Exhibitor and **EDUKSINE PRODUCTION CORPORATION (EDUKSINE)** agree that the screening of the film "**VERDICT**" will be governed by the terms herein set forth:

1. Exhibition Permission.

EDUKSINE hereby permits Exhibitor to publicly exhibit the film "**VERDICT**" Online Screening on **December 1-6, 2023**, 5 days online screening with the **PCAF** employees.

2. Exhibition Format and Equipment.

EDUKSINE shall provide Exhibitor a copy of "**VERDICT**" through google drive or an online link at least 2 days before the screening dates. Exhibitor shall be responsible for all equipment and testing of the link in their equipment. Confidentiality and security of the movie file and promotional materials are highly encouraged. The film's online link shall be deleted after one day from the last screening date.

3. Exhibition Fee.

The Exhibitor will pay the amount of **THIRTY-ONE THOUSAND EIGHT HUNDRED SIXTY-SIX AND 67/100 (Php31,866.67)** subject to Final Withholding Tax equivalent for the hybrid screening. The said amount shall be deposited through:

4. Photography and Publicity Release.

Exhibitor is permitted to take photographs before and after the screening of "**VERDICT**" at the Exhibitor's facility and may use all such photographs for reference and marketing purposes. The taking of video by the audience during screening is not allowed. **EDUKSINE** shall not be a party in any sponsorship to be entered into by the Exhibitor.

5. Intellectual Property and Anti-Camcording Law.

Exhibitor acknowledges and agrees that: i) "VERDICT" is protected by Philippine and International Copyright Laws; ii) Republic Act (RA)10088 also known as the "Anti-Camcording Act of 2010", prohibits and penalizes the unauthorized use, possession, and or control of audiovisual recording devices for the unauthorized recording of cinematographic films and other audio-visual works and or their soundtracks in an exhibition facility, providing penalties therefore and other purposes; and iii) This agreement shall be governed by the laws of the Republic of the Philippines.

Unauthorized recording, uploading, and sharing of the film are not allowed. After the event, the film shall be deleted from the laptop of the exhibitor, and shall not to have any copy of the film in any format or device.

6. Force Majeure.

If either party hereto is prevented in the performance of any act required hereunder by reason of an act of God, fire, flood, or other natural disaster, malicious injury, strikes, lock-outs, or other labor troubles, riots, insurrection, war, or other reason of like nature not the fault of the party in performing under this Agreement, then the performance of such act shall be excused for the period of the delay and the period of the performance of any such act shall be extended for a period equivalent to the period of such delay except that if any delay exceeds six months, then the party entitled to such performance shall have the option to terminate this Agreement.

If the particular screening of "VERDICT" does not push through due to force majeure, **EDUKSINE** and **Exhibitor** shall mutually agree to the next screening date, which should not be held more than six (6) months after the original screening date.

EDUKSINE shall not be held liable in case any untoward incident, such as fire, earthquake, or stampede, will happen during the screening that will result in the injury or death of attendees.

7. Miscellaneous.

This Agreement contains the entire agreement of the parties, and may only be amended in writing signed by both parties.



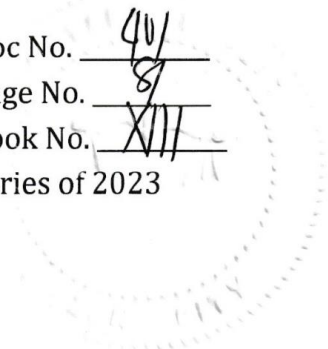
