

CONTRACT OF AGREEMENT

KNOW ALL MEN BY THESE PRESENT:

This Contract of Agreement made and entered into this APR 24 day of 2023, 2023 in Quezon City, Philippines by and between:

The **PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES (PCAF)**, a government agency attached to the Department of Agriculture (DA), created pursuant to Executive Order No. 366, Series of 2004, and the Department of Budget and Management (DBM) approved Rationalization Plan covering the consolidation of the National Agricultural and Fishery Council (NAFC) and Livestock Development Council (LDC) on June 26, 2013, with office address at the Apacible Hall, Department of Agriculture Compound, Elliptical Road, Diliman, Quezon City, represented in this Act by its **Executive Director III, NESTOR D. DOMENDEN**, hereinafter referred to as the **PCAF**;

-and-

ISLAND DRAGON TRANSPORT AND TRAVEL SERVICES INC, a company licensed to operate business under the laws of the Republic of the Philippines with principal office address at 65 F. Balagtas St., Parang, Marikina City, represented in this Act by its **Corporate Secretary, YASMIN EDNILAG**, hereinafter referred to as the **SUPPLIER**.

WITNESSETH

WHEREAS, the **PCAF** requested the procurement of bus rental services for the conduct of the Orientation in Omnibus Guidelines on the Engagement of Agricultural and Fishery Councils on April 25-28, 2023 in Clark, Pampanga through PR No. 23-04-162;

WHEREAS, the **SUPPLIER** is engaged in the provision of bus rental services and had submitted its quotation;

WHEREAS, after due evaluation by the Bids and Awards Committee (BAC), the **SUPPLIER** was declared as the Lowest Calculated and Responsive Quotation, thus, the BAC recommended to the Head of the Procuring Entity (HOPE) to award the above mentioned procurement to the **SUPPLIER**;

WHEREAS, the HOPE has concurred with the BAC recommendation and issued Notice of Award No. 2023-044 dated April 17, 2023;

NOW THEREFORE, in view of the foregoing premises, the parties have agreed to these following terms and conditions:

A. OBLIGATIONS OF PCAF

1. Allocate and disburse funds in the total amount of **Ninety-Eight Thousand Pesos (Php 98,000.00)** to **ISLAND DRAGON TRANSPORT AND TRAVEL SERVICES INC.** for the rental of two (2) unit bus to transport participants



who will attend Orientation on Omnibus Guidelines on the Engagement of Agricultural and Fishery Councils on April 25-28, 2023 in Clark, Pampanga; and

2. Pay the **SUPPLIER** after completion of the services and receipt of the billing statement.

B. OBLIGATIONS OF THE SUPPLIER

1. Provide the required bus rental services for the conduct of the Orientation in Omnibus Guidelines on the Engagement of Agricultural and Fishery Councils on April 25-28, 2023 in Clark, Pampanga for the total amount of **Ninety-Eight Thousand Pesos (Php 98,000.00)**, as follows;

- **Bus Rental (2 Unit)**

Inclusions:

- April 25, 2023: PCAF, Quezon City to Clark, Pampanga
- April 28, 2023: Clark, Pampanga to PCAF, Quezon City
- at least 49 Seaters per bus, inclusive of driver, fuel and oil, toll and parking fees and food of the driver
- Air-conditioned Bus

2. Bill the **PCAF** for the bus rental services rendered; and
3. Acknowledge the receipt of payment by issuing an Official Receipt in the name of the **PCAF**.

C. GENERAL PROVISIONS

The parties shall mutually agree to perform, fulfill, and abide with all the provisions and requirements, and on all matters contained or could be reasonably inferred from the Contract.

D. AMENDMENTS


All stipulations set forth in this Contract shall apply unconditionally, subject to amendments that may be mutually agreed by both parties in writing.






