

CONTRACT OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Contract of Agreement made and entered into this 24 OCT 2023 day of _____ 2023 at Quezon City, Philippines by and between:

The **PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES (PCAF)**, a government agency attached to the Department of Agriculture (DA), created pursuant to Executive Order No. 366, Series of 2004, and the Department of Budget and Management (DBM) approved Rationalization Plan covering the consolidation of the National Agricultural and Fishery Council (NAFC) and Livestock Development Council (LDC) on June 26, 2013, with office address at the Apacible Hall, Department of Agriculture Compound, Elliptical Road, Diliman, Quezon City, represented in this Act by its **OIC-Executive Director, JULIETA E. OPULENCIA**, hereinafter referred to as the **PCAF**;

-and-

ISLAND DRAGON TRANSPORT AND TRAVEL SERVICES, INC., a company licensed to operate business under the laws of the Republic of the Philippines with principal office address at 65F Balagtas Street, Parang Marikina City, represented in this Act by its **Corporate Secretary, YASMIN EDNILAG**, hereinafter referred to as the **SUPPLIER**.

WITNESSETH:

WHEREAS, the **PCAF** requested the procurement of bus rental for the conduct of the **2023 National Livestock and Poultry Forum** in Region IVA on October 25-27, 2023 through PR No. 23-10-493;

WHEREAS, the **SUPPLIER** is engaged in the provision of bus rental services and had submitted its quotation;

WHEREAS, after due evaluation by the Bids and Awards Committee (BAC), the **SUPPLIER** was declared as the Lowest Calculated and Responsive Quotation, thus, the BAC recommended to the HOPE to award the above-mentioned procurement to the **SUPPLIER**;

WHEREAS, the HOPE has concurred with the BAC recommendation and issued Notice of Award No. 2023-155;

NOW THEREFORE, in view of the foregoing premises, the parties have agreed to these following terms and conditions:

A. OBLIGATIONS OF PCAF

1. Allocate and disburse funds in the total amount of **Forty Thousand Pesos (Php40,000.00)** to **ISLAND DRAGON TRANSPORT AND TRAVEL SERVICES, INC.** for the rental of one (1) unit bus for the conduct of the **2023 National Livestock and Poultry** in Region IVA on October 25-27, 2023; and
2. Pay the **SUPPLIER** after completion of the services and receipt of the billing statement.

B. OBLIGATIONS OF THE SUPPLIER

1. Provide the required bus rental services for the conduct of the **2023 National Livestock and Poultry Forum** in Region IVA on October 25-27, 2023 for the total amount of **Forty Thousand Pesos (Php40,000.00)**, as follows:

• **Bus Rental (1 Unit)**

Inclusions:

- October 25, 2023: PCAF, Quezon City to Region IVA
 - October 27, 2023: Region IVA to PCAF, Quezon City
 - 49 Seaters, inclusive of driver, fuel and oil, toll, and parking fees food of the driver
 - Air-conditioned Bus with TV, DVD player and PA system
2. Bill the **PCAF** for the bus rental services rendered; and
 3. Acknowledge the receipt of payment by issuing an Official Receipt in the name of the **PCAF**.

C. GENERAL PROVISIONS

The parties shall mutually agree to perform, fulfill, and abide with all the provisions and requirements, and on all matters contained or could be reasonably inferred from the Contract, such as but not limited to Request for Quotation, Notice of Award and Notice to Proceed duly signed and executed.

D. AMENDMENTS


All stipulations set forth in this Contract shall apply unconditionally, subject to amendments that may be mutually agreed by both parties in writing.




